#### **BOARD REPORT**

**SUBJECT:** Committee for the Assessment of Student Learning (CASL)

The purpose of assessment at Henry Ford College is to gather information on student learning and development that can be used to increase student achievement. The College's efforts to improve student learning through instructional or curricular and co-curricular changes are to be informed in part by effective assessment procedures.

The committee is responsible for the coordination, supervision and communication of assessment activities for the purpose of improving student learning and development. The committee oversees all activities that relate to formal assessment of general education, programs and co-curricular activity outcomes at the College.

Our goal is to improve student learning and development. It involves helping each faculty member set high standards for student learning and development (outcomes), gather, analyze and interpret evidence to determine how well student performance matches those expectations and using the results to document, explain and take action to improve student performance.

### Accomplishments: 2015-2016 Academic Year

- The Higher Learning Commission (HLC) spring 2015 accreditation feedback report indicated that although we "provided evidence of an effective process for assessing student learning," we needed to take action to ensure that assessment of student learning at the institutional level was understood by faculty and staff. To address this need, our fall 2015 Mini Conference entitled "Assessment: Critical Inquiry into Student Learning" introduced our faculty and staff to Dr. Barbara Walvoord's 3-Step Assessment Model. This model was unanimously adopted by CASL Gen Ed and CASL Programs in October 2015.
- CASL co-chairs presented the model and reported the committee's progress to the Faculty Senate in February 2016. Eric Rader, Senate Chair sent the following email dated 3/15/16 to the CASL co-chairs: after your presentation to the Senate last month, senators unanimously approved the following motion, and asked that I convey it to you:

"The Senate appreciates and endorses the report on progress provided by the CASL committees and we look forward to further updates in the near future."

- CASL Gen Ed built pilot projects using the 3-Step model (Outcomes-Evidence-Action).
   Evidence was collected during fall 2015 and winter 2016 semesters and entered into SPOL (Strategic Planning Online).
- Two Gen Ed sub-committees, Computer Technology and Quantitative Literacy presented their action plans for improving student learning at Assessment Day, part of the Spotlight on Program Improvements for the Future (SPIF) on April 14. The remaining three subcommittees are working during the spring/summer semester to finalize their action plans.
- CASL Programs continued to gather data, implement improvement actions and entered their assessment plans and results into SPOL (Strategic Planning Online).

- The CASL committees documented the assessment process in a flow chart, developed forms for data collection, evidence analysis and action plan development to assist faculty.
- The CASL committees developed and approved CASL member roles and responsibilities and a revised Course Application form for courses to be considered as meeting one of our Gen Ed outcomes.
- HFC joined the Higher Learning Commission Assessment Academy to receive assistance with building an institutional culture of assessment. We intend to improve communication about assessment to the College community through the development of a newsletter (presently in draft state), implement Assessment Day (in place, April 2016) and improve the Program Review process.
- In May 2015 faculty and administrators agreed that CASL should be modified to incorporate co-curricular assessment.

### Next Steps: 2016-2017 Academic Year

- **Gen Ed:** Implement their Assessment Pilot action plans and build and begin collecting evidence for our Assessment Cycle 1 assessment plan.
- **Programs**: Implement their assessment action plans and collect evidence for their ongoing assessment plan to support Program Review.
- Co-curricular: Implement their Pilot projects.
- CASL co-chairs: Facilitate Faculty Development workshops at the Division level.
- **CASL Sub-committee:** Develop the Charge, Bylaws and Membership for one CASL with representation supporting General Education, Programs and Co-Curricular assessment.
- **Gen Ed, Programs and Co-curricular:** Implement actions to support the spring 2019 Higher Learning Commission (HLC) Accreditation visit.

The cooling tower is undersized for current needs, leaks water, and needs replacement. As part of the project, the College must repair damaged ceilings in these two rooms. In the second phase, a general contractor will reconstruct the classrooms with new closed cell insulation, ceiling grid and tile, light fixtures, and electrical upgrades. In the fall, after the air conditioning season ends, the final phase will include the removal and replacement of the old cooling tower.

The College invited bid submissions under Sealed Bid #17592. The bid responses appear below. The project design team reviewed the results and recommended an award to the low, qualified bidder.

#### **CONTRACT AWARD**

**SUBJECT:** Polar-Mohr Cutting Machine

The Executive Director of Marketing and Communications requests a contract for the purchase of a Polar-Mohr Cutting Machine, Model D 66 ECO, for the Graphics Center. Used in the graphics and printing industry, this programmable, hydraulic-drive cutting machine trims and cuts production volume quantities of printed materials.

The new cutter replaces an existing old and worn cutter that needs frequent repairs. Polar-Mohr is the sole manufacturer of this equipment and their exclusive, authorized distributor in the United States is Heidelberg USA, Inc. The College requests a sole source award.

The gross sales price of the Polar D 66 ECO Cutter totals \$31,235.60 including freight, rigging, installation, training and warranty. Heidelberg USA offered an additional discount of \$3,365 and a \$1,500 trade-in allowance for the old Polar Eltromat 72CF Cutter and an obsolete and unused Heidelberg Kord 62 press. After discounts and trade-ins, the net price totals \$26,370.60.

#### **CONTRACT AWARD**

**SUBJECT:** Managed Security Monitoring Services

The Chief Information Officer/Director of Facility Services requests a contract for Managed Security Monitoring Services for the College's information technology and internet networks. Services provided by the contractor shall include:

- 1) configure security monitoring for HFC firewalls, domain controller servers, and up to 70 network servers;
- 2) provide a log collector to record events associated with threats to the security of data or IT resources;
- 3) provide log aggregation, log monitoring, and event analysis to determine when security threats occur and to prioritize those events;
- 4) provide a customer portal for ongoing visibility and tracking of security events;
- 5) provide 24x7 up/down monitoring of the log collector;
- 6) correlate, validate, investigate, and prioritize important events; and
- 7) alert HFC staff and deliver actionable intelligence in a timely manner when security threats are detected.

The contractor ranks security events into four priority levels. In highest level, the threat poses an immediate and real threat to the security of data or resources with a very high level of confidence. Immediate action is required and notification will be immediate (24x7x365).

To fulfill these requirements, a local provider, NetWorks Group, Inc., has been recommended by the Supervising Agent for the FBI Cyber Crimes division located in the FBI Detroit office and by Merit Networks, which is part of the University of Michigan and is a primary supplier of internet services to colleges, libraries, school systems, and municipalities in the state. NetWorks Group has also provided IT security consulting services at HFC in the past. The College requests a sole source award. Pricing for these services consist of one-time startup costs of \$8,000 and recurring monthly services of \$5'900 per month, for a total of \$78,800 for the year.

#### **RECOMMENDATION:**

The College administration recommends a contract award to NetWorks Group, Inc. for \$78,800 for Managed Security Monitoring Services, in accordance with NetWorks Group proposal dated May 23, 2016.

#### **CONTRACT AWARD**

**SUBJECT:** Blanket Purchase Order Approval, Fiscal Year 2017

Board policy requires the approval of blanket purchase orders at the beginning of each fiscal year. Blanket purchase orders with a dollar amount in excess of \$13,247 require a separate listing for Board approval, in accordance with Administrative Guideline #6320A.

The attached blanket order list includes the vendor name, purchase order number, a brief description of the order, the department and division responsible for the purchase, and the dollar limit of the order. These orders cover the purchase of goods and services needed to maintain the program and may include emergency purchases. Purchases against these orders shall adhere to Board Policy #2450, which contains Board approved standards for obtaining competitive quotes and sealed bids.

The College uses blanket purchase orders in the following ways: to make repetitive purchases of commonly used low dollar value goods or services; to order standard materials or maintenance supplies which require numerous shipments; and to obtain more favorable pricing through annual volume commitments. In addition to lower purchase prices, the benefits of using blanket orders include fewer requisitions and purchase orders issued, decreased demand for storage space for materials, reduced amounts of paperwork, and lower administrative costs.
